This report includes an introduction explaining the procedure by which the code was compiled and describing generally the types of provisions included in and excluded from the code, comments on specific provisions and appropriate cross-reference tables to facilitate comparison with existing statutes.

#### METHODOLOGY

The codification of the insurance laws introduced on

December 10, 1985 as House Bill 1962, Pr.'s No. 2642, was prepared by
the staff of the Joint State Government Commission. 1983 House

Resolution No. 160, adopted January 24, 1984, directed the Commission

"to organize a task force to codify the laws relating to the business
of insurance in this Commonwealth and modernize their format as part
of the consolidated statutes and . . . report its findings and
recommendations along with appropriate legislation to the General
Assembly."

The Task Force on Insurance Laws, under the chairmanship of Representative Ralph D. Pratt, organized June 6, 1984. It was determined that the resolution called for a codification of the insurance laws, not a revision. The task force agreed that the draft should include the Motor Vehicle Financial Responsibility Law enacted in 1984 as 75 Pa.C.S. Chapter 17. The staff was directed to prepare a draft of the codification and to circulate the draft for review of its accuracy to members of the task force, individuals suggested by them and any others expressing an interest in it.

A comprehensive review of insurance laws 65 years ago led to the enactment on May 17, 1921 of the Insurance Company Law of 1921 and the Insurance Department Act of 1921. These codes incorporated or affected about 100 previous enactments. Commission staff identified over 60 separate statutes relating to insurance which have been enacted over a period of 135 years, including over 50 acts adopted since 1921. These statutes, in turn, have been affected by over 380 separate amendatory acts.

The statutes appropriate for codification were arranged in the order of appearance in Purdon's Pennsylvania Statutes Annotated, as a first approximation to the order in which the sections would appear in the codification. This initial draft was edited to clarify the language, eliminate obsolete expressions and conform the style to the Legislative Reference Bureau's "Pennsylvania Consolidated Statutes. Style Manual." The draft was then re-edited to determine the precise order of the provisions, assign section numbers and supply cross references.

The staff examined a word search printout obtained from the Legislative Data Processing Center to assure the comprehensiveness of the scope of the Code. The printout was also helpful in preparing the repealer and those comments in Part II which refer to statutes not included in the Code.

The draft was continuously revised to include legislation enacted by the General Assembly during the drafting process. This included the act of June 18, 1984 (P.L.391, No.82), known as the

Continuing-Care Provider Registration and Disclosure Act and the act of December 19, 1984 (P.L.1182, No.224), known as the Insurance Premium Finance Company Act. The latest amendatory act to be included was the act of November 6, 1985 (P.L. , No.78).

The draft of the codification and the source notes were circulated for comment as directed by the task force. The Legislative Reference Bureau prepared the bill for introduction. A supplement (1985 House Bill No. 1961, Pr.'s No. 2461) was introduced to serve as a vehicle for corrections, intervening amendments to the provisions that were codified and enactments subsequent to the introduction of the Code (e.g., the act of December 19, 1985 (P.L.\_\_\_, No.97)). The "trailer bill" allows for amendments to the 1083-page Code without the expense of reprinting the latter.

A provision was added directing the Insurance Commissioner to prescribe those regulations that may be reasonably necessary for the exercise of the Commissioner's powers and duties under the Code and for the administration of the Insurance Department (See Code § 304), in lieu of numerous specific provisions in existing law. Furthermore, some revisions to the arbitration provisions of Chapter 71 derived from the Health Care Services Malpractice Act of October 15, 1975 (P.L. 390, No. 111), were made necessary because of constitutional difficulties; these revisions are further explained on pages 6 to 8 and in the comments to the affected sections. With these exceptions the Code is intended to codify the present statutory law without substantive change.

A compilation of the sources of the draft code provisions in the present law is included in this report at page 9. A disposition table showing the location of the sections of present law in the Code is presented at page 153. Comments to certain sections, which appear in Part II, explain language omitted, clarified or modified to reflect subsequent legislative action and court decisions, including invalidations on Constitutional grounds, and reference relevant statutory provisions not included in the Code.

#### SUBJECT MATTER OF THE CODIFICATION

The Code is intended to include the general and permanent law relating to the organization and regulation of the business of insurance. In general the staff used Title 40 of the Purdon's Pennsylvania Statutes Annotated (including the present 40 Pa.C.S.) as a guide to determine the statutes considered primarily within the insurance area. Some statutes were included despite the fact that they do not appear in 40 Purdon's:

- --the act of December 20, 1983 (P.L.260, No.72) (Code §§ 1171-1177). This act deals with the licensure of public insurance adjusters and solicitors by the Insurance Department.
- --the act of June 30, 1923 (P.L.984, No.404) (Code § 4115). This act deals with transfer restrictions regarding membership in organizations providing for mutual benefit insurance and other cooperative associations. The provisions of the act are stated in a form applicable to associations for mutual benefit insurance (Code § 4115). Consequently, the 1923 act is repealed insofar as it applies to associations for mutual benefit insurance.

--the act of February 12, 1984 (P.L.26, No.11), known as the Motor Vehicle Financial Responsibility Law, presently 75 Pa.C.S. Ch. 17 (Code §§ 6301-6398). This act was included at the suggestion of the Task Force on Insurance Laws. The act includes detailed regulation of the coverage required to be offered under automobile insurance policies, and was therefore considered appropriate for inclusion in this Code.

Many other statutes touch and concern the business of insurance; to have included them all would have resulted in a greatly expanded piece of legislation. The following types of statutes concerning the business of insurance are generally not included:

- --workmens' compensation and occupational disease statutes, except those regarding provisions of policies providing liability coverage to employers and regarding the organization of companies authorized to provide such coverage.
- --terms of retirement and disability benefits for public employees.
- --unemployment compensation insurance.
- --insurance covering deposits in financial institutions.
- --authorizations or requirements of public agencies, political subdivisions or public officials to procure insurance and provisions regulating the procurement of insurance.
- --provisions relating to relations between the Insurance Department and its employees, such as civil service regulations.
- -- the State Insurance Fund and provisions relating to insurance coverage of the property of the Commonwealth or its political subdivisions.
- --provisions relating to payments by public authorities on losses covered by insurance.

- --publicly established or publicly financed funds insuring against environmental damage (e.g., the Pest Control Insurance Fund established pursuant to 1967 P.L.517, No.251).
- --provisions permitting other persons to invest in insurance companies.
- --securities regulations affecting insurance companies, inter alia.
- --statutes levying taxes on insurance company income or based on insurance premiums, unless the provisions levying the tax are part of an act otherwise falling within the scope of this Code.
- --insurance proceeds or other insurance-related property as part of an estate or account which is subject to Title 20 of the Pennsylvania Consolidated Statutes (the Probate, Estates and Fiduciaries Code).
- --authorizations or requirements of professional licensees to purchase insurance.
- --requirements to disclose the fact of insurance coverage or insurance charges or terms in connection with the sale or rental of real or personal property.

## REVISION OF HEALTH CARE SERVICES MALPRACTICE ACT

It was necessary to substantially revise the provisions of the Health Care Services Malpractice Act of October 15, 1975

(P.L.390, No.111). In Mattos v. Thompson, 491 Pa. 385 (1980) the Supreme Court held the arbitration provisions of the act unconstitutional because the exclusive original jurisdiction of the arbitration panels, combined with the lengthy delays in disposing of cases brought before the panels, impermissibly infringed upon the right to trial by jury guaranteed under Article I, Section 6 of the

Mattos that the arbitration panels could exercise concurrent jurisdiction if the consent of all parties was obtained to the arbitration proceedings (Op. Atty. Gen. No. 80-2). The Arbitration Panels for Health Care of the Office of General Counsel continue to hold conciliation conferences in cases referred to the panels by the Courts of Common Pleas under 42 Pa.C.S. \$ 7362 pursuant to the local rules of the referring court. In Heller v. Frankston, 504 Pa. 528 (1984), the Supreme Court stated that the Mattos decision had struck down the entire arbitration procedure, not merely its exclusive original jurisdiction feature. However, the Court concluded it lacked power to prescribe an alternative procedure to the one invalidated, noting that the alternative procedure could be provided only by legislation.

The code provides a procedure falling between conciliation conferences and exclusive original jurisdiction as provided under the act. In order to eliminate the constitutional objections raised in <u>Heller</u> and <u>Mattos</u>, the panels are vested with concurrent original jurisdiction to be exercised only with the consent of all parties to the action and only in those judicial districts where reference to the panels is permitted by local rules of court. The procedure set forth in Chapter 71, subchapters B and C, retains the binding arbitration feature of the original act, as this appears to be closer to the legislative intent than a program providing settlement conferences. The Code supplies the "jurisdictional predicate" for

the arbitration panels which was held in <u>Heller</u> to be beyond the court's power to supply.

Revisions to any specific section of the Health Care Services

Malpractice Act are explained in the comments to the Code section

where the revision appears.

### II. Source Notes and Comments

The source for each section of the Code is set forth below.

Comments are added where the provision is other than an edited reenactment of existing law. Comments are also used to direct attention to a relevant uncodified statutory provision.

As used in these source notes and comments, ICL refers to the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, and IDA refers to the act of May 17, 1921 (P.L.789, No.285), known as The Insurance Department Act of one thousand nine hundred and twenty-one.

Omissions of subsections or significant smaller units are explained in the comment to the section in which the omitted material would otherwise appear. Where sections or acts were repealed and not included in the Code, the references to the prior act and the explanation are provided in the Omitted Sections beginning on p. 165.
